

TERMS OF USE FOR THE OBSERVATION DECK AND PLAYGROUND ON THE PREMISES OF “LUBLIN BUS STATION” AT UL. DWORCOWA 2 IN LUBLIN

§ 1

Rules for Using the Observation Deck

1. The administrator of the observation deck and playground at the “Lublin Bus Station”, which is used as an open recreational and leisure space that has been created for the purpose of providing a safe place for spending time during mid-journey breaks while travelling on public transport, is the Public Roads and Transport Authority of Lublin with its registered office in Lublin – hereinafter referred to as the administrator.
2. The following are prohibited from entering and staying on the observation deck and at the playground:
 - 1) persons under the influence of alcohol or intoxicating substances;
 - 2) persons bringing or carrying weapons, explosives, flammable materials, pyrotechnic articles or other dangerous items, alcoholic beverages or intoxicating substances;
 - 3) a person behaving aggressively or otherwise posing a threat to public safety or public order;
 - 4) animals, with the exception for service dogs assisting people with disabilities;
 - 5) children aged 13 and under, unless they are supervised by a person with parental authority, legal guardian or another adult.
3. For safety reasons, the following actions are strictly prohibited on the observation deck:
 - 1) leaning over the railings;
 - 2) running;
 - 3) littering and throwing any items and objects outside;
 - 4) using roller skates, skateboards, scooters, bicycles and other personal transportation devices;
 - 5) bringing in and consuming any alcoholic beverages or intoxicating substances;
 - 6) smoking tobacco or other similar products;
 - 7) damaging and destroying elements and devices located on the observation deck.
4. Parents or legal guardians are responsible for the safety of children. Children may approach the railings only when supervised by adults.
5. The administrator's staff may refuse to admit to the observation deck persons who have violated the provisions of para. 2-4 of these terms of use or order them to leave the observation deck.

§ 2

Rules for Using the Playground

1. Children under 13 must be supervised by an adult.
2. Littering is not allowed on the playground; waste should be disposed of in waste bins.
3. The use of playground equipment and presence on the playground is only permitted on the days and during hours specified by the administrator.
4. It is forbidden to vandalise playground equipment.
5. Due to a threat to health and risk of injuries, the following actions are prohibited:
 - 1) using open flames;
 - 2) entering the playground on a bicycle, scooter, roller skates or other personal transportation devices;
 - 3) destroying or damaging playground equipment.
6. Smoking tobacco or other similar products, consuming alcoholic beverages or intoxicating substances is strictly prohibited on the playground.
7. All playground equipment must be used in accordance with its intended purpose or function.
8. Parents and legal guardians of children are legally responsible for any damage caused by children to persons or property.

§ 3

Final Provisions

1. The observation deck and playground are available during opening hours and on the days specified by the administrator by means of a notice displayed in the bus station building and on the bus station's website.
2. The administrator is not liable for any consequences resulting from the users' misuse of the observation deck or playground and non-compliance with these regulations, as well as general health and safety regulations.
3. In cases not covered by these regulations, the provisions of generally applicable law shall apply, in particular the Civil Code.
